

MEMORANDUM OF UNDERSTANDING

Between

AZERBAIJAN UNIVERSITY OF LANGUAGES

And

UNIVERSITAS PANCASAKTI TEGAL

This Memorandum of Understanding (MOU) is between Azerbaijan University of Languages, represented by its Rector Acad. Kamal Abdullayev, and represented by Universitas Pancasakti Tegal. Its Rector, Dr. Taufiqulloh, M. Hum. (hereinafter referred to as the "Parties"). It is intended to initiate a mechanism for further cooperation in the areas of education, exchange, and research between the respective institutions. By this MOU, the parties have agreed to the following terms:


1. This MOU is intended to facilitate all exchanges and cooperative initiatives between the Parties in the areas of instruction, faculty and student exchange, research, and community service.
2. That the Parties recognize that implementation of any agreement will depend on the academic interests and expertise of individual faculty members and upon the availability of financial resources. Accordingly, joint institutional goals will be accomplished in accordance with separately negotiated school, college, or unit-level agreements implementing them.
3. That a variety of cooperative approaches shall be employed, such as:
 - a. Exchange of undergraduate and graduate students,
 - b. Exchange of faculty members and research personnel,
 - c. Development of joint scientific research, including holding international workshops,
 - d. Development of dual degree programs, joint conferences, and cultural programs,
 - e. Exchange of scholarly and pedagogical materials, including grant of publication rights in one's own collected works and journals,
 - f. Other cooperative efforts may be set forth in separate individual agreements may be arranged.
4. That the financial and/or funding considerations shall become the specific subject of discussion and agreement within the framework of a separate Implementation Agreement negotiated at the school/college level. No financial commitment whatsoever on either signatory to this document is intended or implied.
5. That the subjects of mutual activities and terms of implementation of scientific research results, as well as scientific visits and exchange organization and other

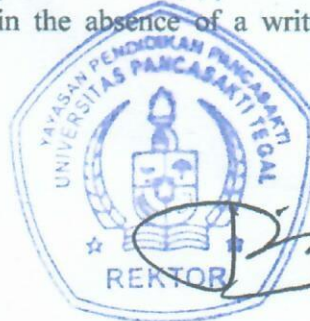
forms of international cooperation shall be specified/stipulated individually in each specific case.


6. That this MOU will be in effect for three years, subject to revision or modification by mutual agreement. It is also understood that either institution may terminate this MOU at the close of any given semester. It is assumed that such action would be taken only after mutual consultation in order to minimize potential inconvenience to the other party to the agreement.
7. That this MOU is not intended to be a legally binding document. Rather, it is meant to describe the nature and cooperative intention of the Parties involved and to suggest guidelines for cooperation. Nothing therefore shall diminish the full autonomy of either institution, nor may any constraints be imposed by either upon the other.

This MOU will remain in effect for a period of three (5) years from the date of the last signature. It shall be automatically renewed in the absence of a written 90-day advance notice of discontinuance by either party.
